Information Item Update on Governor's Budget Workshop	Chief Business Official, Karen Kinney provided Trustees with an overview from School Services of California - Governor's Proposals for 2017-18 State Budget. There is a warning of slower economic growth which forecasts lower than expected state revenues, low growth in Proposition 98 and the Governor's over contribution to the state's Rainy Day Fund. In the fall Proposition 55 was passed, however it did not increase education funding above the Prop. 30 level. Mrs. Kinney shared a slide on Prop. 98 which shows how the funding has changed over time. The Governor's priorities no longer include additional early childhood education, but do include block grants and adding some money into the Gap closure. She also explained the transition from Prop 30 to Prop 55 and how it extends the personal tax increase. For the 2017-18 Local Control Funding Formula (LCFF) new funding is estimated to close the gap between the 2016-17 funding levels and LCFF full implementation targets by 23.67%. The Governor's State Budget also proposes to re-establish apportionment deferrals, shifting \$859.1 million in LCFF costs from June 2017 to July 2017. The Governor is proposing some one-time discretionary funds at about \$48 per ADA, which is a fraction of what the District had last year. Mrs. Kinney explained the LCFF Target Funding Factors for COLA, grade span adjustments, and Supplemental and Concentration grants. Based on the Governor's January budget the District is projecting ADA funding at \$9,413 for 4,576 students with a 2017-18 LCFF Total Revenue of \$43,033,040, based on the first interim numbers we are at a shortfall of \$941,605. She explained the concern over the CalSTRS and CalPERS increases, and how the state will not provide any additional revenue for districts to pay

	this. There will be more budget committee meetings at the state level addressing these concerns, and the next update will be at the May Revision.
Board/Superintendent Comments	Interim Superintendent Joel Shawn shared the La Habra Journal articles on the district page and the front cover featuring new Superintendent, Joanne Culverhouse. Both Dr. Shawn and Dr. Winger thanked the Board and the Community allowing them the opportunity to serve as co-interim superintendents. Trustees thanked Dr. Shawn and Dr. Winger for all they did the past few months. Ida MacMurray thanked the La Habra Journal for the nice article on Washington Middle School Teacher Dr. Pritchard. Dr. Pritchard was selected as a finalist for the California League of Middle School Award. John A. Dobson attended the play at Imperial Middle School last week, thought it was very interesting. He also announced the upcoming California School Board Association meeting will be on March 1 st and would like to see if teachers from and classified staff from the bargaining groups would be able to attend. Sandi Baltes announced the upcoming Citrus Fair and would like to see each school site have a booth advertising the great programs that they have.
