Action Item: 2019 California School Boards Association Delegate Assembly Election	After a motion made by John A. Dobson, and a second to the motion made by Sandi Baltes, Trustees discussed the ballot to be submitted to elect candidates for the 2019 California School Boards Association (CSBA) Delegate Assembly. Trustees unanimously voted to cast the ballot for nine candidates for the 2019 CSBA Region 15 Delegate Assembly as attached to these minutes. ¹⁴
Information Item: ASES Program Update	Board Member Cynthia Aguirre announced that Mark Chavez was unable to attend the meeting and Dr. Carlos will present the ASES update on his behalf. The ASES program is supported by Senate Bill 638 funding, district personnel and use of facilities. It

	provides literacy, academic enrichment, and a safe constructive environment. The grant is on a three-year cycle and the District has recently submitted for the next three years. The current annual grant amount is for \$723,407. ASES is available to all students after school. Dismissal for TK-5 th grade is 6:00pm and 6 th -8 th grade is at 6:02pm. The program is available at all nine sites and currently serves 591 students. The goals for ASES is to provide students with a safe and supportive environment where students are active and engaged in learning. It provides skill building and leadership opportunities. Principals, community and staff are involved in the program. For more information on the ASES After-School program parents can contact Ofelia Hanson at the La Habra Boys & Girls Club.
Information Item: Raptor Visitor Management System	Chief Technology Officer David Soto provided Trustees with an update on the Raptor Visitor Management System being piloted at Walnut School. The system will enhance school security by scanning government issued IDs and compare them against a national sex offender database. The system will print out a visitor badge, which includes a photo, name, date, and destination of the visitor that must be worn during the visit. It also provides exit scanning accountability so staff is aware of who is on campus in the event of an emergency or evacuation. All visitors asking for access to the school beyond the main office must sign in using the Raptor system. Employees and students do not need to check in via the system. Mr. Soto demonstrated how the system works and how it will be monitored by staff.
Instruction and Personnel Action Item: Approval of School Plans for Student Achievement	On a motion made by Ida MacMurray, and a second to the motion by Sandi Baltes, Trustees unanimously approved the Single Plan for Student Achievement, 2018-2019 for Arbolita, El Cerrito, Ladera Palma, Las Lomas, Las Positas, Sierra Vista, Walnut, Imperial and Washington Middle Schools as attached to these minutes. ¹⁵ Trustees thanked everyone involved in putting the plans together. It was a lot of work and the Principals provided a great presentation. Trustees commented on the new template and feel it is much easier to read the plans.

Action Item: Low-Performing Block Grant	On a motion made Sandi Baltes, and a second to the motion made by John A. Dobson, Trustees unanimously adopted the Low-Performing Block Grant to receive one-time block grant funding to support increased academic achievement of low-performing student as attached to these minutes. ¹⁷
Information Item: Williams Uniform Complaint – Quarterly Report	Board President Cynthia Aguirre announced no reports for this quarter.
Information Item: Update on District Goals- Student Achievement	Assistant Superintendent Sheryl Tecker provided Trustees with an update on the District's goals for Student Achievement. She explained that on the California School Dashboard, when one student group meets the criteria for assistance in two or more state priority areas, they are identified as a school district needing Differentiated Assistance. The District has been identified for the African American Sub-group in Chronic Absenteeism/Suspensions. There are two levels of identification for schools;

	Comprehensive Support and Improvement (CSI) and Targeted Support and Improvement (TSI) or Additional Targeted Support and Improvement (ATSI). Of those two, the District was targeted as ATSI. She explained how CSI is pertinent to the explanation of ATSI. When looking at CSI, the schools qualify if they have either all red, all red but one indicator of any other color, all red and orange, or five or more indicators where a majority are red. None of our schools are identified under these areas. For ATSI one or more student groups meet the CSI criteria for two consecutive years. There are 42 schools from 12 Orange County districts that have been identified. Both Washington and Imperial have been identified for students with disabilities and we are working on how to improve our results. The good news with ATSI is that the schools can exit these criteria annually if the subgroup no longer meets the criteria or the status for indicators have increased. Dr. Tecker explained that we will not receive any additional money under the Differentiated Assistance, or ATSI identification, but we can incorporate these students in our already existing SPSA and LCAP plans. The District's next steps include training at the County on Differentiated Assistance, and targeted support and improvement workshops and meetings for Imperial and Washington coaches and psychologists.

It was amazing to see the students able to solve problems without using a calculator. Trustee Rogers attended the pancake breakfast at Applebee's. It was great to see so much parent engagement.
	Trustee Dobson attended the Math Games competition at Washington Middle School and enjoyed watching the students solve the problems. He also attended the Governor's Budget recap meeting hosted by Orange County School Board Association. They shared that there was some money coming in, however the Governor's plan is unclear on how it will be used. El Cerrito's Epic Showcase was very impressive.
	Dr. Culverhouse provided Trustees with a temperament theory card that was given to the Superintendent Leadership Team by Tracy Spears. She referred them to page 154 from "What Exceptional Leaders Know." Dr. Culverhouse also shared the President's Commendation award presented to the District Wellness team for their achievement on national healthy schools. The commendation is presented in grateful recognition of the special efforts and unwavering dedication to the St. Jude Medical Center mission, vision, and values performed by the La Habra City School District.
